- Ultrasound in MAR (24-25 Sept 2021 (moved from 2020 because of covid): hands-on course
  - → Update: this course has been cancelled and no new dates are available at the moment. When it is clear that hands-on course are allowed again, we can organize this. It is a course with a lot of interest and ESHRE wants us to organise more practical hands-on courses, so this fits within this framework.
- **18-20/11/2022** Errors in ART (Athens, Greece) (together with S&Q / Ethics and law / Global & Sociocultural aspects of infertility / Nursing and midwifery).
  - → Update: it is on the ESHRE agenda and the program is final. All speakers have confirmed their acceptance upon moving to 2022.
- Brainstorm ideas on other activities:
  - Possible Campus workshop together with psychology SIG on 'patient counseling about embryo transfer'
     We will explore this collaboration with the SIG Psy and draft a proposal
  - International collaboration: 'embryology for the clinician' (what do MD need to know about the quality in the lab). A course for the MDs related to the QMS and embryology.
    Possibilities for an international webinar or maybe international course, to be explored in collaboration with our international advisor.

### Webinars

Unclear if there is a need for organizing more webinars after the summer. The SIG will look into historical brainstorms to find possible topics and see what can be organised.
